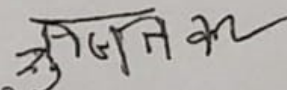

कार्यालय आदेश/OFFICE ORDER

In perusance of Medical Committee Meeting dated 24/07/2025, Director, ICAR NINFET has reviewed different aspects of medical facility extended for regular employee, pensioners and dependents and it has been decided that-

- The cashless limit of indoor medical treatment in case of regular staff members, pensioner and dependents is restricted to Rs 5 lakhs only, above and over of which can be reimbursement as per CGHS guidelines on submission of bill to this Office.
- As per O.M. No. 2-1/2012/CGHS/VC/CGHS(P) dated 01.08.2013, in case of conservative treatment where there is no CGHS package rate, the eligible items are admissible item-wise at CGHS rates or as per AIIMS rate (if there is no CGHS rate) or as per actual rate (if there is no CGHS/AIIMS rate) available for any item. In view of this, it has been decided to follow the said procedure for settlement of indoor treatment/diagnostic tests.
- Sometimes regular staff members/pensioners have submitted bills for reimbursement from non empanelled private hospitals on emergency ground, which does not commensurate with the provision of emergency as per CGHS guidelines. It has been decided that this bills will be duly vetted from Institute part time medical officer/CGHS empanelled AMA/Specialist doctor of Govt hospital and after verification of emergency provision only, the bills will be processed.
- It has been decided that the reimbursement of eligible medicine prescribed by the Doctor (AMA/PART TIME MEDICAL OFFICER) for 10 days will be reimbursed on unitary basis (01 strip or 01 bottle irrespective of number of tablet or capsule it contains).
